## WAIVER

# **Responsibility Statement**

All participants (hereinafter referred to as "Participants") participating in the OGKILS Canada Cup Badminton Tournament must clearly understand and agree to the following terms:

- Voluntary participation: Participants confirm that they voluntarily participate in this
  competition and are fully aware of and willing to bear any risks that may arise during the
  participation process, including but not limited to personal injury, property damage,
  illness, etc.
- Personal health: Participants confirm that their physical health is suitable to participate in badminton competitions, and have consulted professional doctors for advice regarding their health conditions.
- Personal responsibility: Participants promise to strictly abide by the rules and regulations of the Committee of OGKILS Canada Cup Badminton Tournament and obey the management and arrangements of the organizer and/or volunteer during the tournament. If any accident occurs due to violation of the rules or their own fault, the responsibility shall be borne by the participants themselves.

# **Scope of Exemption**

The Committee of OGKILS Canada Cup Badminton Tournament and its staff, volunteers, sponsors, venue providers, other contestants and related parties (hereinafter referred to as "event-related parties") do not assume any responsibility for the following situations:

- Accidental Injury: Any form of physical injury or health problem that occurs to a
  participant during the competition or while traveling to and from the competition venue.
- Property Damage: Loss, damage or theft of a participant's personal property.
- Natural disasters: Cancellation, postponement or other inconveniences and losses caused by force majeure such as earthquakes, floods, typhoons and other natural disasters.
- Other risks: other losses or injuries of any kind caused by unforeseen reasons or personal reasons of the contestant.

#### **Accident and Health Clauses**

#### Health Statement

Participants should truthfully disclose the state of health to ensure that the organizer understands their health status and promptly inform the organizer of any health problems during the competition. The participant is in good health and does not have any physical discomfort or disease (including congenital heart disease, rheumatic heart disease, hypertension, cerebrovascular disease, myocarditis, other heart disease, coronary artery disease, severe arrhythmia, and high blood sugar) or hypoglycemia, and other diseases that are not suitable for badminton), participant can attend the competition normally; during the

competition, unrelated personnel are strictly prohibited from walking around in the aisles of the venue. All consequences arising from personal health reasons or improper behavior will be borne by the participant.

### Risk Awareness Statement

I fully understand that participating in training, competitions and related activities may face potential dangers, and I may encounter injuries or even life-threatening accidents. I will do my best to participate in the competition with a responsible attitude towards my own safety. If I discover or notice any risks and potential risks during the participation process, I will immediately terminate the participation or inform the competition organizer.

## Emergency Medical Treatment

I agree to accept on-site first-aid medical treatment provided by the organizer(s) and/or volunteer(s) during the competition, and bear the related expenses incurred for hospital treatment.

#### Insurance Recommendations

The Committee of OGKILS Canada Cup Badminton Tournament recommends that participants purchase appropriate accident and health insurance to cover possible medical expenses and other related expenses.

# **Use of Photos and Images**

Participants agree that the photos and video materials taken by the event-related parties during the competition can be used for event publicity, promotion and related media reports without paying any fees.

### **Application of Law**

This waiver shall be governed by *Canadian Law* and any disputes arising out of this clause shall be submitted to the Municipal Courts in Montreal for judgement.

## **Disclaimer of Liability**

I and my heirs, representatives and agents hereby release and agree not to hold any parties responsible for the event (including but not limited to the The Committee of OGKILS Canada Cup Badminton Tournament and its staff, volunteers, sponsors, venue providers, other participants and related parties) any liability that may arise due to any form of injury, illness, property damage or other losses incurred during my participation in the OGKILS Canada Cup Badminton Tournament 2025. I understand and agree that the event-related parties will not bear legal liability or financial compensation due to any form of accident, loss or injury.
